

IMPORTANT NOTICE: ROADS

A representative of the SCCCA Board of Directors met with John Lyons, Public Works Administrator and Joshua Bellotti, Director of Engineering of Hillsborough County on Monday, March 21, 2022 to discuss the future of SCCCA road repair and resurfacing.

Attached is a current list of funded and scheduled projects.

The Board feels that the proposed repairs are not adequate. We are asking for the help of the membership. The Board of County Commissioners will be determining the 2023 Road Budget by late May to mid-June, 2022. **YOUR INPUT IS IMPORTANT AND NEEDED.** Your Board is asking you to contact **all of the Commissioners listed below** to direct more road funding towards SCCCA roads. The Commissioners are also considering a voter referendum to reinstate the 1% Hillsborough County Sales Tax for Transportation. It is important you give your input. A lawsuit was filed and the tax was defeated in court. The wording of the overturned referendum was such that 60% to 65% of the money was allocated to public transportation not solely for roads. Ask the commissioners their thoughts on how funds will be distributed in the new referendum.

It is important that all members participate as our voice needs to be heard.

SCCCA BOARD OF DIRECTORS

ROAD REPAIRS:

- New Bedford Drive (from 2254 New Bedford Dr to Opal Lane) – Work order issued to contractor. Target completion mid-April.
Once the County has contractor pricing, they will determine if they have some ARP funds that could be put towards extending the New Bedford resurfacing to Flamingo. This may be a few months out.

The following locations are also likely a few months out:

- Seton Hall Drive (W. Del Webb Blvd. to Bunker Hill Drive)
- Bentwood Drive (W. Del Webb Blvd. – approximately 100')
- Faxton Drive (1625 to W. Del Webb Blvd.)
- Bluewater Drive (1348 to 1403 Bluewater Drive)
- Del Webb Blvd (several sections not yet determined)

SIDEWALK REPAIRS:

- Allegheny Drive – issued to contractor and construction has started.
- Club Manor Drive – issued to contractor, construction not yet started.

These locations are pending award of a new contract, expected this summer:

- Cherry Hills Drive
- South Pebble Beach Blvd.
- Stoneham Drive

MOBILITY/GOLF CART PROJECT:

- Rickenbacker Drive (from Valley Forge Blvd. to E. Del Webb Blvd. – includes milling/resurfacing and shared use of golf cart pavement markings.)
Scheduled to begin mid-April.
- North Pebble Beach Blvd (from SR674 to just east of Caloosa Blvd. – includes milling/resurfacing)
- Four-lane divided section from SR674 to just south of Dedham Drive (shared use golf cart pavement markings)
- Two-lane undivided section – Dedham Drive to Caloosa Blvd. (dedicated striped lane for golf carts)
- Scheduled to begin May 9
